URGENT – Government pulling the rug from beneath the UK’s small brewers

We are writing to you as a matter of urgency, on behalf of the nation’s small breweries and the Campaign for Pubs. Besides having publican and pub campaigner members, the Campaign for Pubs also represents small brewers who believe in a vision of a freer, fairer, more sustainable UK pub and drinks industry. This letter is from the Campaign for Pubs and breweries listed below. You will note that one of the signatories of this letter is a brewery in your own constituency.

Many small breweries and their customers are utterly dismayed at the announcement that the Government intends to alter Small Brewers Relief by changing the threshold at which Small Brewers Relief starts to taper, from 5000hL to 2100hL. Small Brewers Relief was conceived as a progressive measure to help level-up the wholesale beer market and promote brewery growth. This change does the opposite.

This means that a number of the UK’s small breweries (including in your own constituency) will shoulder an increased tax burden, which is devastating news. For the Government to have announced this now, when these same breweries have been hit hard by the COVID-19 pandemic, is staggering and flies in the face of claims that the Government is committed to helping smaller businesses survive.

This announcement comes at a time when most small independent breweries have already missed out on the government support made available to their counterparts in the hospitality industry, in the way of cash grants or a Business Rates holiday. Sadly, this decision by the Government will almost certainly lead to the loss of jobs and breweries.

Although a consultation is now offered on the detail, it appears that an arbitrary decision has been made in respect of reducing the 5000hL threshold to 2100hL. Could you please explain on what basis that 2100hL figure was selected? Could you also please share any impact studies conducted in advance of this decision?

The UK government appears to have capitulated to lobbying from a small number of medium sized and larger breweries, who wish to protect their businesses from open competition and reduce the tax burden on their companies by increasing it on others. Frustratingly, that is at the expense of disincentivising, if not prohibiting, the growth of smaller breweries. The key lobbyists in this regard style themselves the ‘Small Brewer’s Duty Reform Coalition’ - a tiny group of medium/large sized brewers.

Far from ‘saving the British pint as we know it’, they are actually seeking to end the production of many much-loved pints by undermining smaller competition and reducing the choice to beer

drinkers. It is yet another example of the wholly dishonest presentation in the beer and pub sector that is commonly employed by larger interests pushing their own aims. You have been misled by a group of brewers who appear to have a direct line into the Treasury, whilst ignoring the needs of many smaller breweries. We urge you to rethink this decision and to listen to the whole brewing community.


It is extremely disappointing that the UK Government continues to respond to the wishes of larger business, while ignoring the needs of small enterprise - exactly as has happened with the decision in the summer statement to provide huge amounts of support to chain restaurants and pub-restaurants, whilst not offering any help to the pubs that need it most. The smaller wet-led pubs, micropubs and taprooms hammered by that announcement and competitively disadvantaged against the High Street brands, are also the venues that are more likely to serve the local small brewery beer that this latest measure will harm.

Small breweries are part of our national fabric and play a vital role in the economy. They create more jobs than larger breweries and they pay disproportionately more tax into Treasury coffers than large breweries. They bring local flavours and variety to our pubs. They do not deserve to be put out of business in order to secure the dividends of larger brewery shareholders. Moreover, as we head toward trying financial times, my sense is that the Government's message really doesn't want to be about shutting-down entrepreneurship possibilities and the growth of small businesses in order to protect larger ones.

We look forward to engaging in the subsequent consultation and making the case for supporting, rather than penalising, the nation's small brewers. In the meantime, it would be helpful for us to understand what information was provided to the Treasury in the conduct of this alarming and highly questionable decision.
